Characterization of distribution 2013

A distribution by a corporation to its shareholders is treated as a dividend for US federal income tax purposes to the extent it comes from current or accumulated earnings and profits ("E&P") and as a return of capital to the extent that it exceeds E&P.

In 2013 Nordic American Tankers Limited ("NAT") distributed a total of \$41.7 million to its shareholders. Based on the fact that NAT had no current or accumulated E&P at the time of these distributions, NAT believes that all of these distributions are treated as a return of capital for U.S. federal income tax purposes.
