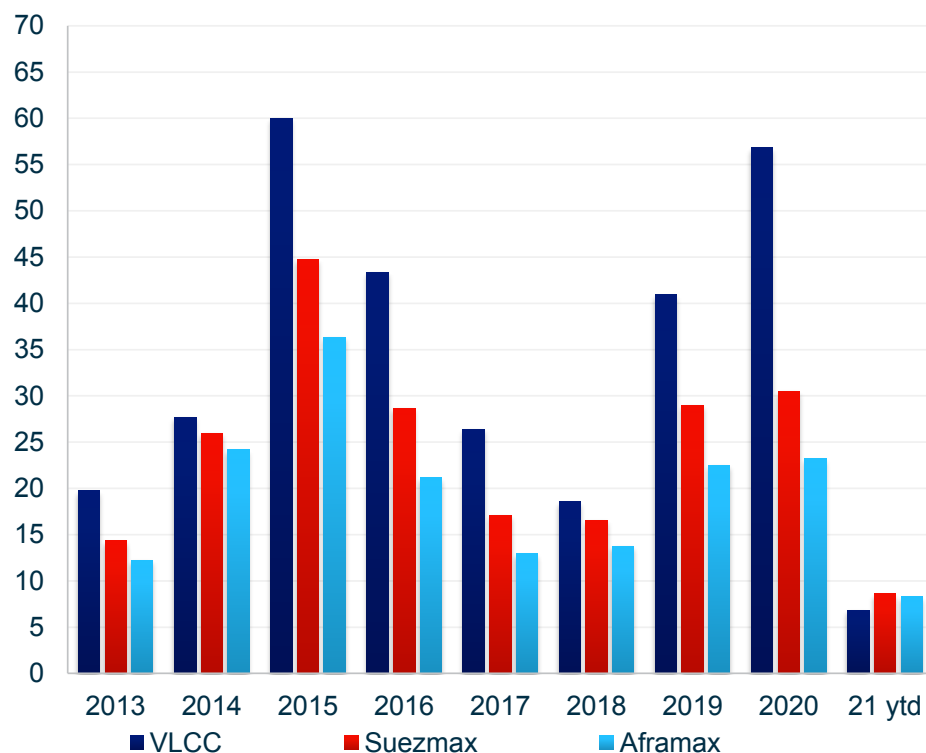

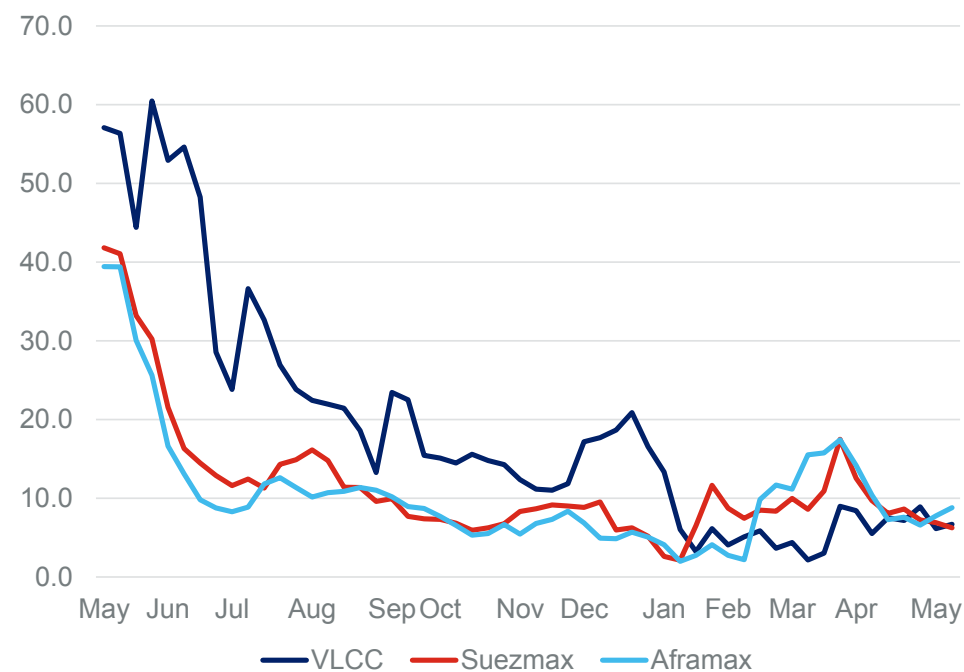

Weekly TC results in US\$ k/d for crude carriers

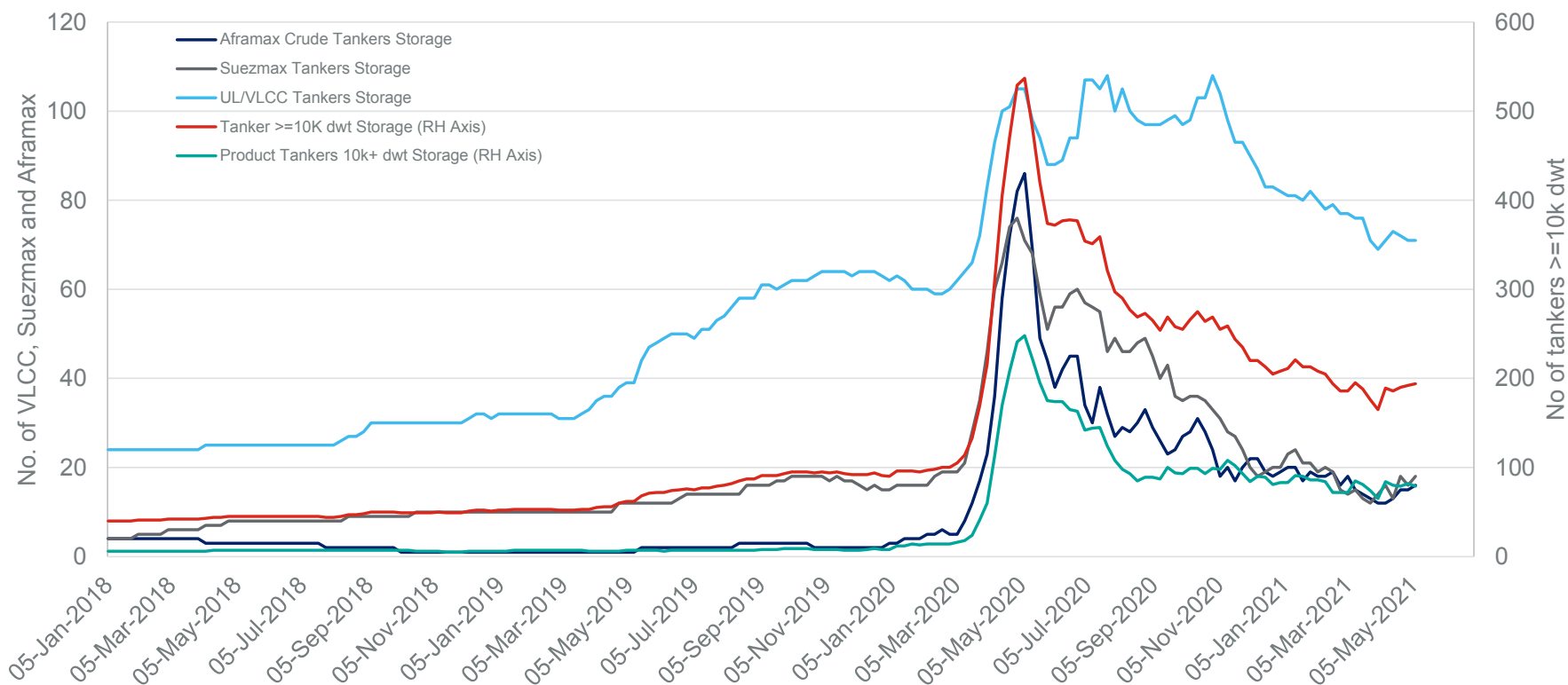

Weekly no of tankers

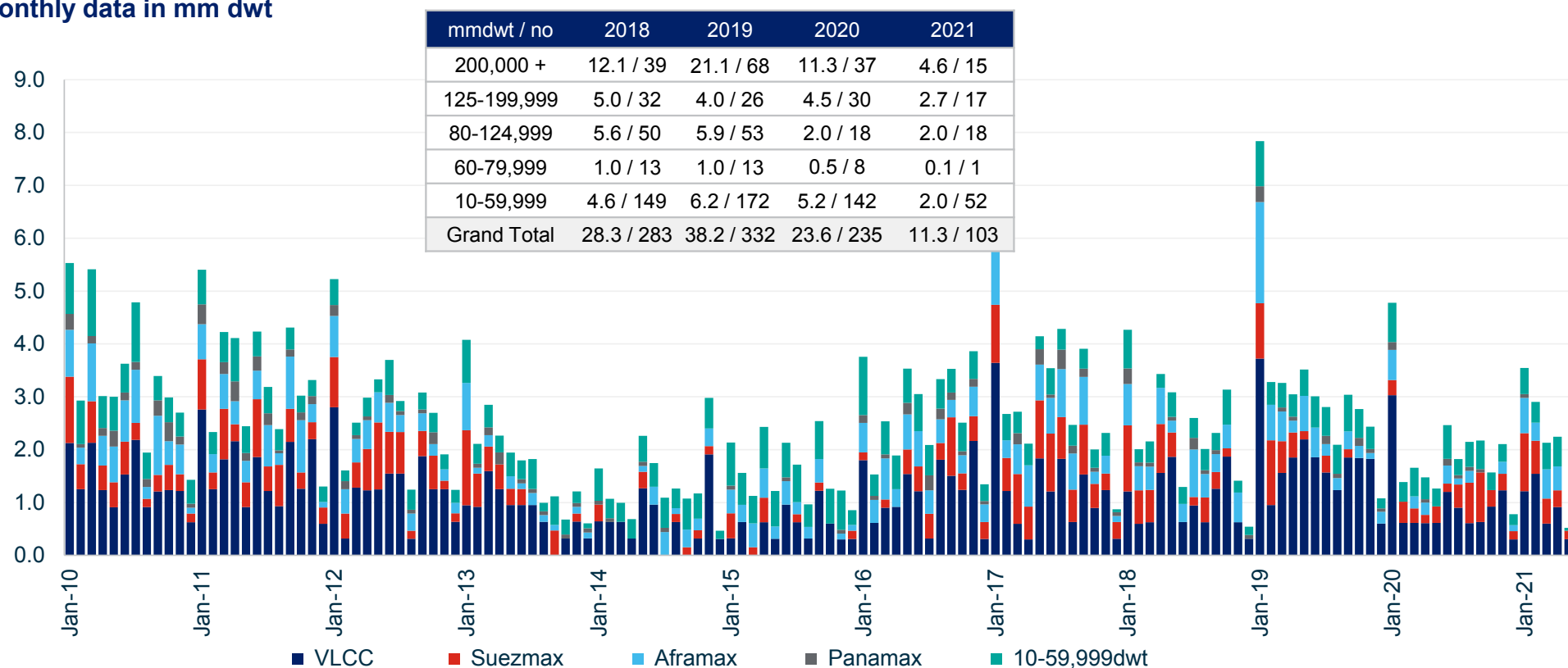

Monthly data in mm dwt

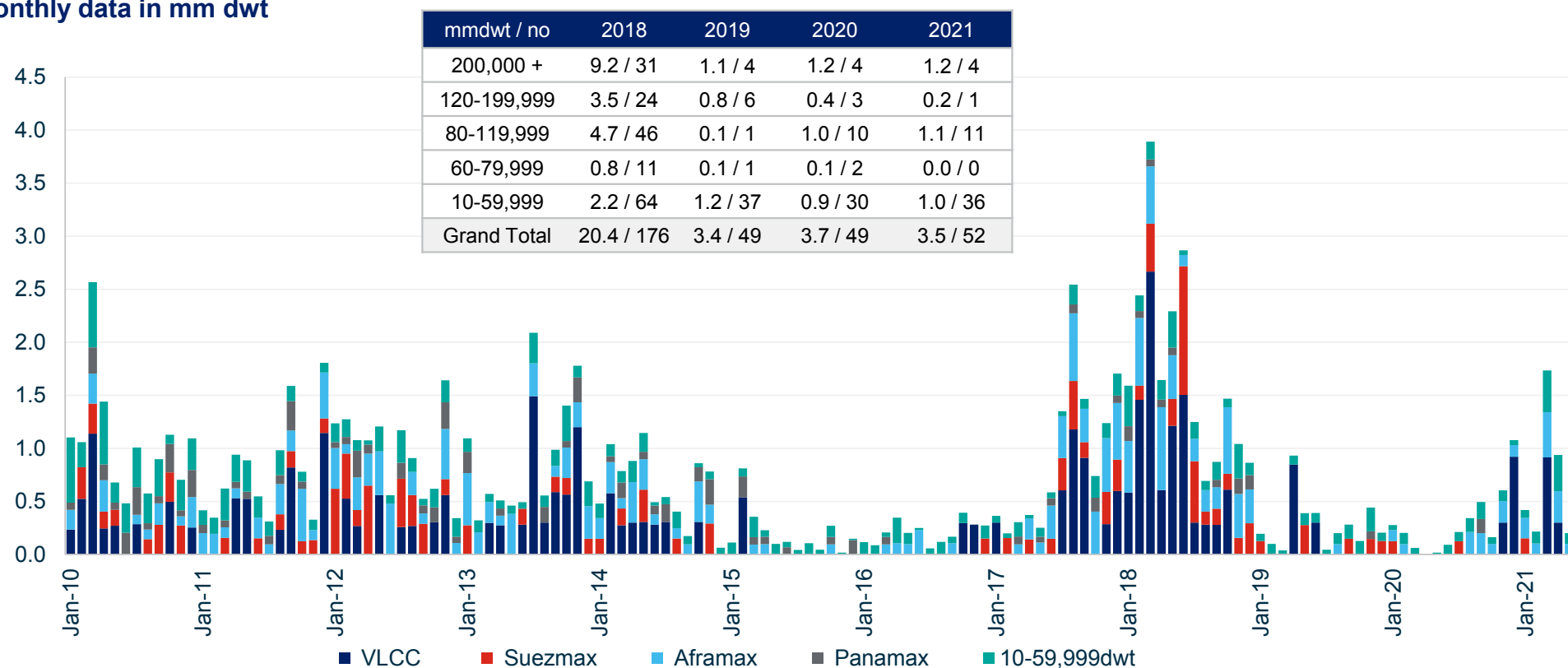

Monthly data in mm dwt

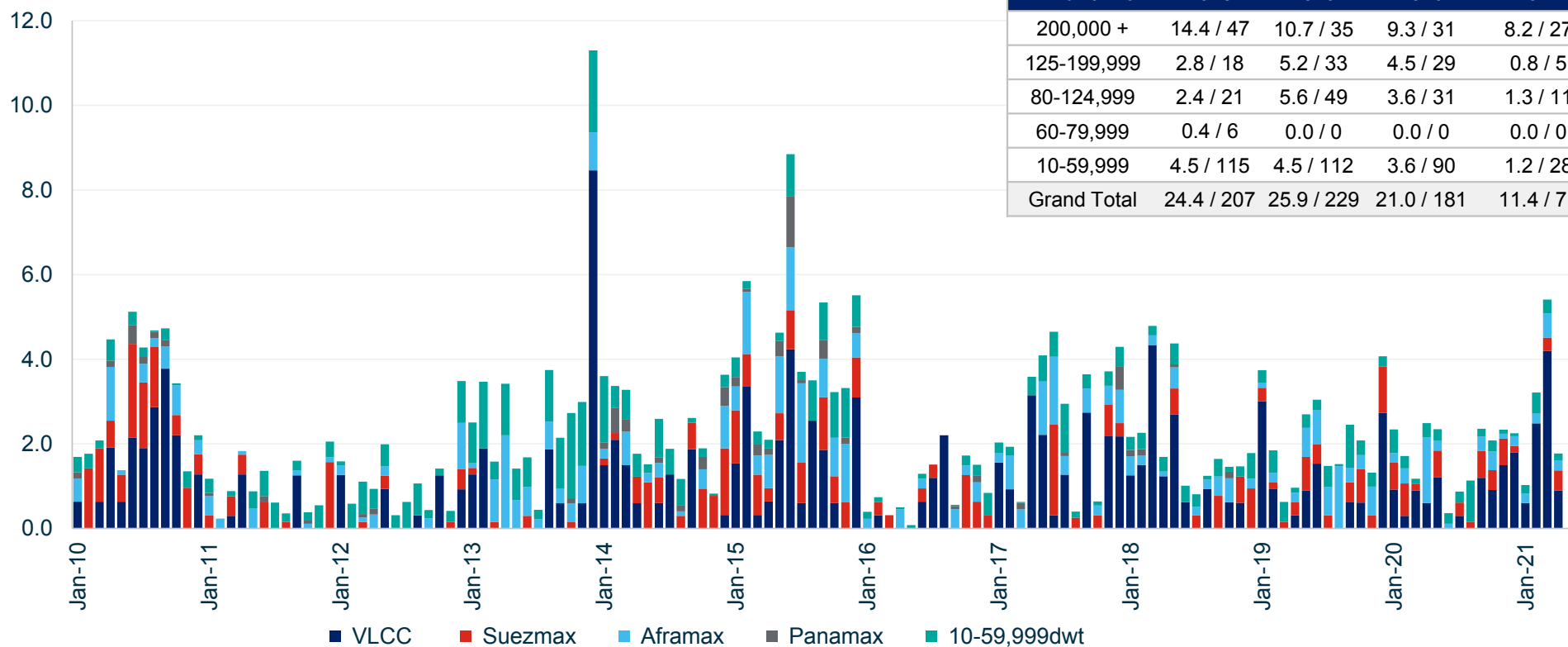
